0% for CKD Models with 2020 Year Make and 2019 Year Make.  
5% for CBU Models with 2020 Year Make.

In-line with recent announcement of the National Economic Recovery Plan (PENJANA) by Prime Minister YB Tan Sri Muhyiddin Yassin, the Malaysian automotive sector is set to benefit from temporary sales tax incentives for both CKD and CBU vehicles in the year of make 2020 and CKD vehicles in the year make of 2019. These tax incentives fall under the 2 key thrust of the PENJANA objective, which aims to propel local businesses and stimulate the economy as we move through the pandemic recovery period. As such, the current 10% sales tax for CKD vehicles will be fully waived to 0% while sales tax for CBU vehicles will be halved to 5%. The new sales tax incentives are only applicable for new registration from 15 June 2020 to 31 Dec 2020.
